
1. Educating Students

- 1.1. Increase collaboration with Legal Research and Writing and other courses with a writing component to improve student research skills
- 1.2. Be more intentional in supporting the needs of our diverse student body through our collections
- 1.3. Increase outreach to student organizations to assess and support their needs and improve awareness of library services, spaces, and collections



2. Climate & Culture

- 2.1. Explore additional options for supporting wellness in partnership with the Law School
- 2.2. Celebrate the contributions of our diverse community through library displays or other means
- 2.3. Prepare a space use analysis to inform and communicate how library space aligns with law student, faculty, and staff needs





3. Research & Scholarly Support

- 3.1. Explore new ways to strengthen research assistance to the faculty including providing additional support to and from student research assistants
- 3.2. Broaden outreach to faculty to increase their awareness of the library's electronic resources
- 3.3. Further expand efforts to increase access to and visibility of faculty and student scholarship
- 3.4. Explore opportunities to support scholarship through data gathering, collection, reporting, and management



4. Outreach & Public Engagement

- 4.1. Collaborate with internal and external partners on presentations to students and others to improve their knowledge of legal research and law librarianship
- 4.2. Explore collaboration with community partners to provide access to unique legal materials through new repository collections such as the Herman Goldstein Collection, Wisconsin Tribal Laws Collections, and Wisconsin Constitutional History Collection
- 4.3. Explore the creation of an online library card application for community members
